## PATHWAYS AGREEMENT FOR THE TRANSFER OF STUDENTS FROM OZARKS TECHNICAL COMMUNITY COLLEGE INTO THE BACHELOR'S DEGREE PROGRAMS AT THE STATE UNIVERSITY OF NEW YORK, EMPIRE STATE COLLEGE

## Introduction

This articulation agreement assures that students completing an Associate of Arts (A.A.), Associate of Science (A.S.) or Associate of Applied Science (A.A.S.) degree at Ozarks Technical Community College (OTC) may transfer to State University of New York (SUNY) Empire State College for completion of baccalaureate degrees. This articulation agreement establishes procedures to ensure implementation of the policy and defines the opportunity for graduates of OTC to obtain the appropriate baccalaureate degrees (B.A., B.S., B.P.S.) at SUNY Empire State College.

Objectives of the Agreement

- 1. To promote the easy transition of qualified OTC transfer students into baccalaureate degree programs at SUNY Empire State College.
- 2. To provide specific information for transfer students wishing to pursue baccalaureate degrees at SUNY Empire State College.
- 3. To provide ease of access for transfer students seeking an alternative, non-traditional educational mode of baccalaureate learning at SUNY Empire State College.

Terms of Agreement

- SUNY Empire State College agrees to accept the entire associate degree from OTC toward a baccalaureate degree for transfer students who successfully complete associate degrees at OTC and meet Empire State College's admissions requirements.
- 2. SUNY Empire State College faculty mentors will work with the community college students to allow for enrollment at OTC for additional courses beyond the associate degree with appropriate advising; the student may complete up to 80 lower-division credits (including the associate degree) at the community college as long as the courses meet baccalaureate degree requirements. (For more details concerning SUNY Empire State College baccalaureate degree requirements see Appendix A, Table 1). Empire State College's Center for Distance Learning will work with OTC to provide 1) prematriculation advisement to interested students, 2) outreach and training to faculty and transfer office staff at the community college to provide program information, and 3) student information sessions.
- 3. Each college agrees to give the widest possible publicity to the establishment of this agreement such as inclusion of procedures and descriptions in publications and webpages of each school. This literature clearly specifies the persons or offices to contact at each institution. OTC agrees to advise interested students of the provisions of this agreement. In addition, advisors from Empire State College shall be available at appropriate times to explain educational opportunities available to students and provide transfer information.

4. This agreement becomes effective when all signatures are affixed and remains in effect for five years from that date (of last signature). The agreement may be amended or renewed by mutual consensus and will become formalized through revision of this agreement. Matters of concern that affect this articulation agreement should be brought to the attention of the Director of Collegewide Academic Review or the Dean of the Center for Distance Learning at SUNY Empire State College, and to the Vice President for Academic Affairs at OTC for discussion and amendments.

Guidelines of the Agreement

1. Students successfully completing OTC requirements for AA, AS, AAS degrees will be able to transfer all credit earned for that associate degree to SUNY Empire State College, including "D" grades that are part of the completed degree. If a completed associate degree is not transferred toward an SUNY Empire State College degree program, "D" grades are not transferable.

2. The maximum advanced standing (including credits earned through prior learning assessments) allowed toward a bachelor's degree is 96 credits, which means that students must complete minimally 32 credits at SUNY Empire State College. (See Appendix A, Table 1, Empire State College Bachelor's Degree Requirements for more details.)

3. Any courses taken at OTC beyond the associate degree will be evaluated for transfer separately from the associate degree based on SUNY Empire State College's advance standing policies.

4. There is no statute of limitations regarding the age of acceptable learning substantiated by transcript except in some areas (i.e. technologies, science) where that learning may be outdated and may not be accepted if it is crucial to the structure of a degree program's concentration.

5. Students will be given the opportunity to complete all requirements for the bachelor's degree in a closely related area of concentration (as specified in Table 2). For students who have completed associate degrees that are not closely related to the Baccalaureate Degree area of concentration, additional studies may be required to complete their degrees and, in these cases, transcripts will be evaluated on a course-by-course basis to achieve maximum transferability.

6. All students need to complete the application process and meet all admissions criteria before being accepted to SUNY Empire State College.
